The Sec Gen deliberated on the following points before the august house:

- Congratulated newly elected/re-elected CS and NEC members.
- Explained the provisions of maternity leave circular.
- Appealed to the divisional leaders to gain knowledge on various circulars.
- The Sec Gen The maximum time given to of NF to deliberate in the recent Information Sharing Session held in the Virtual Mode.
- The concern on the lack of appropriate number of members in Division Council Meetings.
- The status of the wage revision and the vetting by the government, likely milestone wage revision.
- The difficulty in securing cost-free arrears in this wage revision.
- The need for the Division Leadership to develop liaison with the Division Management and the need for collection of important data like participation in one hour strike matching with the data given by CO.
- In spite of the fall in NSP the New GOIBS-22 gave Additional IB.
- The proposal of flexible office timings & digital attendance with Google tracking.
- The unbelievable Area Opening Circular a great achievement with anywhere Business Credit with 100% Credit in Jeevan Utsav Policy and the sale of CLIA Channel being better than our DO Channel..
- The uniform confirmation norms applicable for PDO's.
- The possible concept of Lady Career Agent and inauguration by the FM.
- The heart-warming experience of Meet Sec Gen Program being more than the Meet MD program.
- Informed about the program of flag hoisting at Dwarikadhish temple arranged by the Rajkot Division.
- The Index Plus Credit to DOs is more as compared to earlier ULIPs.
- The Amritbaal Plan Entry Age reduced to 30 Days and DO Credit is Term Based.
- The NF demand for Stagnation Increment after 2 Yrs since most DO's ineligible for 5<sup>th</sup> Stagnation Increment since average cadre age at entry is high and during service period decrements attracted.
- The expectations of 100 % cost-free arrears up to the notification.
- The lack of recruitment initiatives and the unhappiness of the management and the possibility of taking harsh steps.

- The suggestion by A Board Member to take harsh steps against those who do not recruit and if necessary change the regulations/special rules.
- The NF demand of adding the special allowance in basic pay or to exclude it from cost calculation.
- The demand of no negative impact on appraisal due to wage revision, demand of considering the pre revision remuneration for Spl. Rules. Suggested management to make it a part of gazette notification on their argument that it will contradict with Spl. Rules.
- All Zones and Division Associations to strictly follow the constitution and zero tolerance for constitutional violations.
- The need to relinquish any post in the organization immediately on retirement and the necessary amendment in constitution
- All units to conduct the Biennial GB meets well in time without any delay.
- The credit to Joint Front on the achievement Family Pension.
- The strategy to select date of strike in view of the G-20 Meeting.
- The inclusion of Apprentice Period in total service period and the negotiations there of.
- The benefit to IB Earners due to relaxation in 2<sup>nd</sup> Year Lapsation.
- The failure to hold ICC Meetings and many Circulars not being implemented in divisions;
- The Income Tax Refund of Rs. 5.81 Lacs to NF.
- The Division Secretary to avoid any association with any private trainers to avoid data leakage and the NF Logo should be shared.
- The Formation of NFRIFWI (Retired DO's Union under NF banner) on 67<sup>th</sup> Foundation Day 19<sup>th</sup> January 2024 and an appeal for Voluntary Donations and that only NFRIFWI is the union of retired DOs approved by NFIFWI and the constitution of this new union to be approved by this NEC, with the suggestions/changes suggested & approved.
- The NFRIFWI has got its PAN and have also opened a bank account. Suggested one change in eligibility for being member – the person who was member of NFIFWI at retirement, but only those can become an office bearer who don't have dual membership and/or have not opted for LICA/CLIA/any other scheme introduced by LIC in future.

- The need to once again to fight the IRDAI against open architecture proposal decide our strategy since it is now recommended by the Parliamentary Committee

- The Sec Gen generously thanked the Kolkata Divisions for taking care of his health during his hospitalization.

- The DO Cadre is a link between the customer and management and the most influential person in LICI.

- The challenges from our competitors, the IRDAI, etc.

- Post the listing of LIC in May 2022 we are now in Quarterly Cycle every 3 Months instead of the Yearly Cycle like earlier times and the investors are keener on ratio, than on volumes.
- The persistency ratio is lowest on NOP and premium after 1<sup>st</sup> year, reasons since our competitors sell in HNI group whereas we sell in all spectrums of the society therefore LIC's ticket size is lower because of the large number of policies (we sell 2 crores of policies). The other reason for low persistency ratio is wrong selling due to agency year ending cases, competitions and wherever the instalment is below Rs. 1000/- the lapsation is 80% and for instalment premium Rs. 2000/- the lapsation ratio is 70%.
- We should move away from low Sum Assured Policies and avoid selling minimum SA as per plan provisions a major reason of lapsation.
- The agents need more and more handholding in recent years.
- The relevance of Par and Non Par Policies the ratio being 8.8% but now with the introduction of Jeevan Utsav it is on the rise.
- The concept of introducing loyalty reward to existing customers.
- Introduction of 'Swanivesh'.
- In the case of Post Office Maturity Pay-outs 60% Maturities are reinvested whereas in LIC's case it is just 1.5%.
- There are 15 Crore policy holders with only a Single Policy and the people youngsters, especially in IT and other industries are mostly untapped and with population and income growth and an increasing number of senior citizens
- The selling of Single Premium does not affect the NSP since the SP comes from lump sum payment whereas the NSP comes from savings.
- There should be a focus on the Sale Jeevan Shanti, Jeevan Akshay, Jeevan Utsav, Cancer Cover and Bima Jyoti.
- The sale of our Par Products like Jeevan Labh Jeevan Lakshya and Jeevan Umang is quite encouraging.
