2118. ADV DEAN KURIAKOSE:

Will the Minister of FINANCE be pleased to state:

- (a) whether the Government has any data of the number of Life Insurance Corporation of India (LIC) agents working in the country and their average monthly earnings from that;
- (b) if so, the details thereof, State-wise;
- (c) whether the Government anticipates any fall in their earnings after the Bima Sugam portal launched by the LIC;
- (d) if so, the details thereof;
- (e) whether the Government proposes to compensate the LIC agents for the fall in their earnings due to the launch of Bima Sugam portal; and
- (f) if so, the details thereof and if not, the reasons therefor?

ANSWER

- (a) to (b): The details of number of agents of Life Insurance Corporation of India (LIC) and their average monthly earning State-wise, as provided by LIC, are placed at Annexure A.
- (c) to (f): Insurance Regulatory and Development Authority of India has issued the IRDAI (Bima Sugam Insurance Electronic Marketplace) Regulations 2024 to provide a regulatory framework for setting-up an Insurance Electronic Marketplace called Bima Sugam. Bima Sugam will feature assisted sales model which will be an agent / intermediary led model where agents can onboard their customers, sell and service the policies effectively. It will enhance reach and connectivity while reducing operating costs for the agents and intermediaries. It will improve productivity by allowing agents and intermediaries to handle all types of policies life, non-life, health *etc*. from a single portal, eliminating the need to manually process or log into multiple insurer portals, thereby increasing agent's earning and providing stability of income.
