Reg: Clarification on Prescribed Expense Limit-Promotion from D.O. to ABM(S)

This has reference to Promotion of Development Officers as Assistant Branch Manager(S) in the cadre of Assistant Administrative Officer-Promotion Round for the Year 2017-18.

We have received a reference from Meerut Division regarding Expense Limit to be taken for considering eligibility of a Development Officer for promotion to ABM(S). The said Development Officer is aged above 50 years and posted at a place where basic expense limit is 20%. As he is aged above 50 years but less than 55 years his prescribed expense limit as per Special Rules 2016 is 22%. His Cost Ratio in last appraisal year is 21.14% and he has applied for promotion.

In this connection the notification for promotion stipulates that "The Development Officers ... who have worked within the prescribed cost ratio during each of the last three appraisal years are eligible " whereas Rule 5 (3) of Special Rules 2016 stipulates that " The prescribed expense limit mentioned in sub rule (m) of Rule 2 is for the purpose of considering imposition of disincentives only wherever required. For all other purposes, the basic expense limit only shall be applicable."

Further in *Appendix* - *B* Proforma for considering promotion as Assistant Branch Manager (Sales) in the cadre of Assistant Administrative Officer in respect of Non-Matriculate Development Officers.] the data of "Basic Expense Limit" is to be mentioned.

In view of this, we request you to guide us whether Basic Expense Limit or Prescribed Expense Limit is to be taken for considering eligibility of a Development Officer for promotion to ABM(S).
